PLAYER RELEASE

Acting on my own behalf and also on behalf of my personal representatives, heirs, next of kin, successors and assigns, I hereby:

a. b. I fully understand that I cannot hereafter make further claims or seek any further recovery of any nature whatsoever against Des Moines Coed Volleyball Club, based upon, arising out of, or in connection with the Activities, and I hereby expressly waive all future unknown claims caused by, or alleged to be caused by, any act or omission by Des Moines Coed Volleyball Club.

This release, indemnification, and waiver shall be construed broadly to provide a release, indemnification, and waiver to the maximum extent permissible under applicable law.
